Questionnaire for GOP Senatorial Candidate TOM CAMPBELL

"With liberty and justice for all." Thus ends our pledge of allegiance to the flag with a ringing commitment to all citizens. Unfortunately, liberty and justice remain an unrealized dream for Asian American. Two main concerns are stated below.

First, based on publicly available government statistics, Asian Americans have the least opportunity to enter management when compared with women and all other major racial minorities; a rate of progress that will take 75 years to erase the inequity in spite of having the highest educational attainment. It has been read into the Congressional Record by Senator Thomas Carper of Delaware.

Only 1.7% of our Article III Federal judges are Asian Americans, only 1 of the 179 Circuit Court Judges is an Asian American, while 5% of our nation's legal professionals are Asian Americans.

Therefore, we, Asian Pacific Americans, wish to know your answers to the following questions:

- (1) If elected, will you help urge the Labor Department to focus on enforcing Executive Order 11246 on behalf of Asian Americans, since in the past similar efforts have already been made on behalf of women and other minorities?
- (2) If elected, will you vote for the Senate confirmation of Goodwin Liu who has been nominated as an Appeals Court Judge in the 9th Circuit?
- (3) If elected, will you emphasize a) admitting more highly skilled workers, and b) giving larger quota for family reunion in any Immigration Reform Bill that arrives before the full Senate?
- (4) If elected, will you work with us, regarding a Hate Crime provision dealing specifically with the kind of violence against Asian Am. in big cities like San Francisco, Oakland and Philadelphia? **Yes**
